The Northumberland Line

This leaflet provides information, including details of how to have your say, on our proposal to close Palmersville Dairy level crossing and replace it with a new pedestrian underpass.

The proposal for Palmersville Dairy level crossing is one element of the Northumberland Line project. The Northumberland Line project will revolutionise rail travel in southeast Northumberland by bringing passenger trains back into service between Ashington and Newcastle.

The Northumberland Line aims to stimulate and support economic growth, regeneration and community development in Northumberland and the surrounding regions by providing new and improved transport links for local people and businesses.

The line is currently anticipated to open to passengers by 2024.

Why are we seeking your feedback?

In November and December 2020 we undertook a public consultation on the Northumberland Line project. As part of this consultation, we asked for feedback on the closure of Palmersville Dairy level crossing and the option of replacement access being provided via a new pedestrian footbridge.

We are now consulting specifically on plans at the level crossing as we are now proposing an underpass to maintain access across the line.

We are seeking your views on the designs for the pedestrian underpass and works as outlined in this leaflet, including any ways in which you feel they could be improved. You can share your comments by accessing our response form at: nland.uk/palmersvilledairy

Your feedback will be used to review the current proposals and inform the designs ahead of submission of a planning application in Summer 2021.

As part of the planning application a Statement of Community Engagement will describe the process of public consultation on the proposals for Palmersville Dairy and how this feedback has informed the submitted proposals.

You will have a further opportunity to comment on the planning application for Palmersville Dairy level crossing when it is submitted to North Tyneside Council, as the Local Planning Authority.

Palmersville Dairy level crossing

The existing pedestrian level crossing known as The introduction of faster and more frequent trains 'Palmersville Dairy' currently connects the Bellway on the Northumberland Line means that the existing Industrial Estate to the south with the residential level crossing will need to be closed for safety estates to the north along the route of the Forest reasons; the replacement pedestrian underpass Hall 5 Public Right of Way (PRoW). provides a safe crossing for pedestrians.

An underpass located immediately to the north of the level crossing continues the PRoW by providing pedestrian access under the Tyne and Wear Metro line.



Indicative design

The underpass is anticipated to move to the west of the existing level crossing to ensure compliance with industry standards for construction, accessibility and safety; this will require a diversion of the existing PRoW.

The construction of an underpass will require The construction requires the creation of a temporary moving significant amounts of earth, and this will new haul road from Whitley Road to the site and a change the appearance of the local area, including temporary compound at the site.

An indicative plan showing our proposals for the Palmersville Dairy underpass is shown below.

the removal of a number of trees and shrubs. It is not possible to construct the underpass without removing these trees. Once the underpass is constructed compensatory planting will be provided. More information about our approach to landscaping, the environment and on how construction will be managed to minimise disturbance to local residents and businesses is currently being developed. The principles we will be working to are summarised on page 83 of the 2020 public consultation booklet.

The duration and start date for the construction of Palmersville Dairy underpass is to be confirmed. We will seek to minimise the effects of construction works. If closure of the PRoW is required, the duration of closure would be as short as possible.

The land needed to build the underpass is in private ownership; negotiations with landowners are ongoing and may inform the details of the design.
